### 1 Objective

The purpose of BUS 313 is to build upon and enhance the knowledge and skills gained in introductory courses to help you better understand the global economics and financial markets that will impact your careers and lives, and to begin to provide experience using these tools to make business decisions. This course covers:

- International trade: comparative advantage, tariffs and quotas, and commercial policy;
- International finance: balance of payments, exchange rates;
- Banking and international economic institutions. Global financial crisis;

- Regional issues in global economy;
- Ethics topics, in particular the U.S. Foreign Corrupt Practices Act (FCPA);

Consistent with the mission and academic focus of the Shidler College of Business, the international emphasis of this course will be on the Asia-Pacific region.

### 2 Materials

**Required Textbook:** Gerber, J. International Economics, (7th ed.). Pearson Education Inc. *Pearson MyLab Economics is required for this course.* You have three options to obtain MyLab Economics:

- Purchase the textbook in the UH bookstore is the student value edition with MyLab Economics access card (ISBN 9780134640266).
- Purchase the eBook with access to Pearson MyLab Economics with a reduced price (\$99.99).
- If you already have a textbook (like a used copy), you can purchase just the Pearson MyLab Economics access (\$69.99).

In addition, homework will be made on Pearson MyLab Economics website as well. Please see the end of the syllabus for the registration guide of MyLab Economics, and register with your UH email address before January 25.

**Required Readings:** U.S. Foreign Corrupt Practices Act (FCPA) fact sheet from the U.S. Department of Justice (DoJ).

**Lecture Notes and Readings:** Lecture notes and readings will be posted in advance on Laulima, as will web links to videos and articles referenced in class. You are encouraged to download lecture notes, to facilitate note-taking and comprehension of the material presented. This syllabus can be downloaded from Laulima as well.

ECON 130 and ECON 131 or consent.

### 4 Requirements

Attendance Policy: Attendance is highly recommended. Experience indicates that there is a strong and positive correlation between attendance and exam scores. Moreover, to protect the privacy of UH students and avoid unwanted interruptions (such as zoom-bombing), the course's zoom sessions only accept users registered with hawaii.edu email address.

Moreover, I will take the zoom attendance record for in-class group projects as part of the inputs for group participation grade.

**Homework:** There will be six homeworks, all will be made on Pearson MyLab Economics website. The homework corresponds to the chapters as follows:

- Homework 1: Chapter 1 and 2;
- Homework 2: Chapter 3;
- Homework 3: Chapter 4 and 5;
- Homework 4: Chapter 6;
- Homework 5: Chapter 9;
- Homework 6: Chapter 10 and 11.

Please submit the homework at MyLab Economics website in the due date before the due time. MyLab Economics does not accept late homeworks. Students with medical excuse can ask for an extension: please E-mail the Graduate Assistant for help no later than 24 hours after the due date and time, together with the doctor's note. Submitting your homework online is the only official way to prove you have finished homework on time - The graduate assistant will not accept other "proofs," including the homework answer creation time, access, or modification time stamp.

Doing homework is probably the most effective way of mastering the course content. It is also important since it reflects the priority areas to which you should give attention.

**Group Project:** In a group of four to five individuals, students will work on four course projects. Each project will focus on a specific assignment that relates to assessment of countries as places to do business. Each group project is worth up to 15 points: 5 points for individual participation and 10 points for quality of the group work product.

- Group Project 1: Chapter 1 and 2;
- Group Project 2: Chapter 6;
- Group Project 3: Chapter 9;
- Group Project 4: Chapter 10 and 11.

**Exams:** There will be three open-book and open-note exams, using the Laulima website:

- Map test: The background information about the Asia Pacific and North America region;
- Midterm: Chapter 1 to 7;
- Final: Comprehensive with a focus on Chapter 9, 10, and 11.

Students must have a written medical excuse to be absent from an exam. The make-up exams are generally harder than the regular exam.

**Grading:** Your course grade will be based on a reasonable curve over the weighted sum of grades accumulated on the assignments, projects and exams. The weighting scheme is:

- Homeworks 30%
- Group projects 20%
- Midterm exam 20%
- Final exam 30%

The guidelines for letter grades are as follows. Plus or minus grades will be used to distinguish performance within letter grades.

- A = demonstrates outstanding mastery of topics and outstanding ability to apply and extend concepts;
- B = demonstrates above-average mastery of topics and ability to apply them;
- C = demonstrates mastery of topics and ability to apply them;
- D = inadequate demonstration of topic mastery and application;
- F = grossly inadequate demonstration of topic mastery and applications.
